- Must be qualified and committed to adhere to all the pageant requirements and Rules & Regulations
- Must speak fluent English and living full time in the United States

2. **COST:** \$600.00 Non-refundable entrance fee - If Virgelia Productions, Inc. determines that you are not qualified to be a contestant, your payment of \$600.00 will be refunded to you, less a \$25.00 application processing fee.

**NATIONAL COSTUME – For the National Costume Competition –** It must be symbolic to your country's culture and ancestral costumes

**EVENING GOWN – For the Evening Gown Competition –** Very elegant ball gown, queenly, regal with the utmost elegance befitting for a queen

**EVENT DRESS – For all your special appearances before and proceeding to the pageant day.** White formal elegant short cocktail dress.

**REHEARSALS –** 4 inch min. stiletto heels, neutral color; no platforms or sandals. Black top Virgelia Productions will provide the leggings.

### ADDITIONAL ITEMS TO BE PURCHASED FROM VIRGELIA PRODUCTIONS:

**SHOES -** Delegates wear the same style/color shoes for the opening dance and the swimsuit competition **\$45.00**

**ROYAL PIN -** Rhinestone Royal Crown Pin to be use to pin the ends of the Delegates sash **\$20.00**

**SWIMSUIT SARONG -** This will be used for the swimsuit competition **\$20.00**

On the pageant day, all delegates must arrive at 11:00 AM at the venue. Delegates must prepare their hair and make-up in the venue's dressing rooms. Each delegate may bring only one (1) chaperon inside the dressing room. For each additional chaperone the contestant will be charge \$50.00 per extra person in the dressing room up to a maximum of three (3) per delegate.
12. Five winners will be chosen. All cash and gift prizes are awarded subject to complete fulfillment of the winner's obligations during their respective twelve (12) month reigns, unless otherwise modified by Virgelia Productions, Inc. Mrs. Latina Global-Queen will receive a combination of cash and gift prizes with a retail value of One Thousand Dollars, including scholarships and other gift certificates, sash and crown. All other runner-ups will receive a sash and crown. Virgelia Productions, Inc. reserves the right to distribute the prizes at any time within twelve (12) months from the pageant day.
